- Continued to work with the Inter-Provincial Council (IPC) attended an IPC Zoom meeting in August 2022 and was represented on the Formation Guidelines Task Force
- Continued to assist communities through the *Flos Carmeli*, the OCDS provincial website, email, telephone calls, and personal contact.
- Developed an index for OCDS Legislation.
- Began to develop and provide training sessions for communities using communications technology.
- Updated the OCDS Provincial website to ensure that it is as "user-friendly" and secure as possible.

Dear Sisters and Brothers in Carmel,

Love: The Desire of our Being



t Memorare

Remember,

O most gracious Virgin Mary, that never was it known that anyone who fled to thy protection, implored thy help, or sought thine intercession was left unaided.

Inspired by this confidence, I fly unto thee, O Virgin of virgins, my mother; to thee do I come, before thee I stand, sinful and sorrowful.

O Mother of the Word Incarnate, despise not my petitions, but in thy mercy hear and answer me. Amen. We as the community of believers, The Church, have just celebrated the Incarnation of God's Word for us. This Word has taken on our humanity in the Sacred Person of our Lord and Savior Jesus Christ, made known to us and manifested to us wrapped in swaddling clothes in his mystical marriage to us. Christ is the Incarnation of God's Word of Faithfulness to us. He is THE Eternal Covenant. How often do we consider this Mystery? Do we ever ask, "Why this commitment?" "What impelled God to this?"

We as a people are driven by the desire to simplify difficult ideas or concepts, to make them understandable at least to ourselves and help us to explain to others. Unfortunately, in our attempts to simplify, we also tend to lessen the depth and meaning of the concept in question. We do the same thing with the Christian concept of love so that the profound commitment of this mystery can be grasped. Many times, this simplification may lead to explaining love by reducing it to sentimentalism - a caricature of the essence of genuine love. As contemplatives, do we ever take time to ponder the question of love? We allow the unbelieving dominant culture to reduce the Mystery of the Incarnation into a national holiday with plump cupids, tinsel, and twinkling lights. Granted that these are *meant* to be signs of something deeper but unfortunately no one takes the time to teach that there is a deeper meaning to the signs. The result being that there have been succeeding generations that have assumed that the sign was understood until we come to a generation that not only does not understand the signs but questions their validity and begins to look for signs that are valuable or significant to them, and we begin the process again.

As a Christian community we each possess a need for "something other," for something transcendent. This awareness of "the Other" can be deepened by taking time to reflect more on the mystery of the Love of God for us. This reflection will help us in our witness to an unbelieving world of the timeless truth of the Gospel that we have received.

"In this love of God which man meets in Christ he experiences not only what true love is but also at the same time, and unanswerably, that he, sinner and egoist that he is, has no true love. He experiences both aspects in one: the creature's limited love and its guilty frigidity...one

must start from the beginning to re-learn what love really is." Hans Urs von Balthasar, *Love Alone*, p. 51

"The most certain sign, in my opinion, as to whether or not we are observing these two laws [love of God and love of neighbor] is whether we observe well the love of neighbor. We cannot know whether or not we love God, although there are strong indications for recognizing that we do love Him; but we can know whether we love our neighbor [1] In 4:20]. And be certain that the more advanced you see you are in love of your neighbor the more advanced you will be in the love of God, for the love His Majesty has for us is so great that to repay us for our love of neighbor He will in a thousand ways increase the love we have for Him. I cannot doubt this."

The OCDS Local Council Election Process

(See Part 1 – Pre-Election Requirements and Suggestions in the Fall 2022 Flos)

Please review **Section XVI: Community Elections** from the OCDS Provincial Statutes for the Oklahoma Province. *The information below is taken from the Statutes and from the Provincial website unless otherwise noted.*

At this time all nominating committees should be appointed and working to fill the ballots for the upcoming local council elections. The elections for each community and study group in the Oklahoma Semi-Province must be held prior to May 1, 2023.

As a review of Part I: Pre-Election Requirements and Suggestions see below. For more details, please refer to the Statutes and to the article on Pre-Election matters located in the Fall 2022 Flos Carmeli.

- 1. At least three (3) months prior to elections, the members of the nominating committee are introduced to the community.
- 2. It is suggested that at least one (1) month prior to elections the nominating committee submits the names of the nominees for the ballot to the local council. The local council approves or disapproves the names submitted.
- 3. At least three (3) weeks prior to the elections a list of the candidates shall be given to the community.
- 4. If any candidate has already served two (2) consecutive terms, to be elected to a third consecutive term requires a postulation from the Provincial. This must be done before the election. Please send your request for a postulation to our Provincial Delegate, Father Stephen Sanchez at stephen.sanchez@carmelitefriarsocd.com with a copy to your visitator.

Please provide Fr. Stephen the following:

- Name of your community,
- City of community,
- Name of person requiring a postulation to serve a third term,
- The positions she/he has served in the last six (6) years, and
- The reason this person is needed to serve an additional three (3) years.

Part II: The Election Process

- 1. The elections are to be conducted in accordance with recognized parliamentary procedures, such as Robert's Rules of Order, with <u>particular provisions</u> set forth in Section XVI of the OCDS Statutes.
- 2. Only professed members (first or definitive) are allowed to be on the ballot and only professed members (first or definitive) may vote.
- 3. Members must be present to vote.
- 4. Nominations from the floor shall not be accepted.
- 5. Write-in votes are valid if the nominee is eligible and willing to serve.
- 6. Voting shall be by secret ballot.
- 7. Incumbent President shall preside at the elections.

Election of the President

- 1. The Spiritual Assistant shall invoke the guidance of the Holy Spirit. In the absence of the Assistant, this shall be the duty of the incumbent President.
- 2. Election of the President is on a separate ballot. For study groups, President can be on the same ballot as councilor(s).
- 3. Candidates are elected by a majority vote. The Majority vote is a number greater than half the valid votes cast.

4. If no candidate receives a majority vote, the two (2) nominees receiving the highest number of votes will run off on a second ballot. If the second ballot produces a tie, there shall be a third and final ballot. If a tie is on the third ballot, the candidate with seniority of profession wins. If there is a tie in length of profession, then seniority by age shall determine the election.


Election of Councilors

- 1. There are three (3) councilor positions on the local council for a Canonical Community.
- 2. Each council position is voted on separately.
- 3. The candidates for President who are not elected are automatically placed on the councilors' ballot.
- 4. The entire list of candidates shall be on the ballot for the first council position.
- 5. Candidates not elected for the first council position shall automatically be on the ballot for the second council position.
- 6. Candidates not elected for the second council position shall automatically be on the ballot for the third council position.
- 7. In the case of a tie, on any of the three (3) councilor ballots, please refer to the rules in Section XVI of the Statutes, which are summarized above in number 4 under Election of President.

The final vote count shall be recorded in the community minutes.

The newly elected council shall assume its duties at the conclusion of the meeting in which they were elected.

Post-Election Matters

Please become familiar with the Constitutions, Articles 46, 47, 48, 50-55 and the Provincial Statutes, Section XVI

The elections are over, and we have a newly elected president and three councilors.

Congratulations! Now what? Pursuant to the Provincial Statutes, the newly elected council takes office at the conclusion of the community meeting in which they are elected. The previous president, councilors, and formation director positions are vacated as soon as the newly elected council assumes its duties.

The Secretary and Treasurer continue to serve until new appointments are made by the new council.

It is the obligation and duty of each community member -- but especially the local council -- to be very familiar with the legislation of our Order. Therefore, make it a priority to study the Constitutions, Statutes, and Ratio until you are well versed in their contents. The job of the council will be much easier if the council members are well versed in the legislation.

Director of Formation

Probably one of the first orders of business for the new council is the election of a Director of Formation.

- Section XVI.6 of the Provincial Statutes states that the new council shall elect the Director of Formation after prayerful discussion and discernment.
- Before electing the Director of Formation, consult with the Spiritual Assistant (see Constitution, Article 50).
- The Director of Formation must be definitively professed.
- If the Director of Formation is elected from one of the new council members, the candidate with the next highest number of votes on the last councilor ballot is made a councilor (Statutes, Section XVI.7).
- It is suggested that the election of the Director of Formation be by secret ballot.

DO NOT let anyone tell you that a Director of Formation must be appointed immediately. This is not true and very ill-advised. This position is very important to the council and to the community. Each member of the council should pray to the Holy Spirit for discernment and guidance in this decision. The council should prayerfully make recommendations and discern the qualities needed for serving in this position.

THE PRIMARY RESPONSIBILITY of the council is the formation of the members of the community (see Constitution, Article 46). The council will handle any formation matters that may arise before the appointment of the Director of Formation. Do not rush into a decision.

Hand-off Meeting with Outgoing Council

A hand-off meeting is **strongly** recommended pursuant to Section XVI.8 of the Statutes. The new council should not be thrown into a position blindly. It is important that the outgoing council communicates to and informs the new council members of important matters, upcoming tasks, and unfinished business. Council files, records, and forms should be transferred. Due to Covid-19, many councils did not do this at the last triennium elections, and it proved disastrous for some councils and communities. It is helpful when the president and/or some of the councilors are serving a second term (on the new council), so that council member terms are staggered, and continuity is maintained.

What should be discussed and transferred at a Hand-off Meeting?

Suggestions:

- Any forms used in conducting community business, such as agenda, roster, attendance, directory, and interview forms
- Financial Matters may stay with the Treasurer, but the President should be advised where these documents are located:
 - o yearend financial statement,
 - o bank records,
 - o bank documents,
 - o any forms or bank documents needed to change signatures on checks, and
 - o three (3) year financial budget.
- Any matters that will carry over into the new triennium:
 - o disciplinary actions or warnings to a member, any written correspondence to members,
 - o the most recent visitator's report provided to the local council,
 - o any correspondence from the Provincial Council (PC) and the Provincial,
 - o current roster and financials sent to the PC for this year or for the past year,
 - o upcoming retreat matters,
 - o community job descriptions and positions currently held by members,
 - o any old business not completed by the outgoing council,
 - o any work in progress,
 - o new business not completely addressed by the outgoing council,
 - o a copy of the yearly calendar of items to be addressed by the council, and any information needed to coordinate the location of monthly meetings, donations for meeting rooms, and all requirements and rules of the facilities used.

• Formation

- o formation files,
- o personal member files,
- o interview notes,
- o formation syllabus,
- o formator training and formator information,
- Binders or handbooks for the president, director of formation, and councilors, if any.

Calendar of events

It is beneficial to the new council if the election occurred after the new year's formation has started. This allows the new council time to handle other business and not be frantic to set up formation, educate formators, and all other formation requirements immediately after taking office. Aside from electing a director of formation, the new council should set up a yearly calendar, or review the yearly calendar provided by the previous council and make any changes.

Suggested items for the calendar (To Do list):

First Month: elect the director of formation, schedule the hand-off meeting, appoint a secretary for council (can be a council member), appoint a secretary for community meetings (can be the same as the council secretary), and appoint the treasurer.

Second and Third Months: finalize the yearly calendar, and review formation and formators. Look at what has been planned for the community's yearly retreat and what actions must be taken when turning in any documents required by the PC, appointing a Spiritual Assistant, preparing a yearly budget, changing signatures at the bank


Other Months: organize Feast Day Masses and celebrations, group formation, guest speakers, review of community policies, interviews with persons in formation, and any other formation matters brought to the attention of the council. Don't forget to schedule on the calendar the yearly renewal of promises during the Easter Season (see Constitution, Article 12 and Provincial Statute, Section I.8).

Look at future meeting dates and determine if any meetings need to be rescheduled or set up for a different day due to facility requirements or conflicting holidays.

Hopefully the above information is helpful and not more confusing. It really isn't as hard or overwhelming as it appears. The Provincial Council is always available to help. If you have any questions, please do not hesitate to contact the Visitator for your community.





Fr. John Henry Bordeaux, OCD 1936 – 2022

Fr. John Henry Bordeaux of the Mother of Grace, OCD, entered eternal life on November 30, 2022, at the age of 86. He was born in Lafayette, Louisiana on February 6, 1936, entered Immaculata Minor Seminary in Lafayette at the age of 14.
